QUESTION: Can officials wear clear face shields? With and without a mask?

ANSWER: Yes, clear face shields may be worn with and without a mask.





QUESTION: An official tests positive for COVID-19. What is the protocol for allowing them to officiate again?

ANSWER: At the present time TASO does not have an official protocol, although UIL has information.





QUESTION: If an official tests positive during the season, will TASO provide insurance?

ANSWER: TASO provides liability and accident insurance. More information is available under MEMBER SERVICES for INSURANCE (TASO website).





**QUESTION:** When will clinic modules and testing close?

ANSWER: Both clinic modules and testing will close on 15 September. (Officials must complete both before they can officiate any level match.)





#### Feedback from Area AD's

As of right now, these are the impressions received:

- R1: Masks may be worn at the discretion of the official.
- R2: A little less defined. Some AD's have talked about R2 wearing one.





#### Feedback from Huffman Scrimmage

- R1: Some wore masks (whistles inside masks), some not.
- R2: Some wore masks (whistles inside masks), some did not.
  - Electronic whistle sound was hard to hear by R1.

Coaches'/Captains' Meeting







- Coaches'/Captains' Meeting
  - Verify uniform/player legality.
  - Cover ground rules and any special activities.
  - There is no coin toss to start the match. Visiting team serves first in the first set, with teams alternating in subsequent non-deciding sets.
  - Coaches may NOT mutually agree to have home team serve first.





#### BEGINNING A MATCH

- 1. Teams will be on endlines during introductions and anthem.
- 2. R1 starts by pointing to endlines (pointing at teams), whistles, and bring arms to attack line for "good luck" wave.
- 3. After the "good luck" wave, R1 whistles for players to go to their positions. R2 (no whistle or motion) assists teams get to their positions.





- END OF SET (PRIOR TO NON-DECIDING SET)
  - 1. R1 whistles, awards winning point, shows fault. R2 (no whistle) follows by repeating point and fault.
  - 2. R1 whistles, shows "End of Set" signal (#21). R2 (no whistle) repeats end of set signal.
  - 3. R1 whistles, shows "Release to benches" signal. R2 does NOT show this signal.
  - 4. R2 directs clock to start.





- END OF SET (PRIOR TO DECIDING SET)
  - 1. R1 whistles, awards winning point, shows fault. R2 (no whistle) follows by repeating point and fault.
  - 2. R1 whistles, shows "End of Set" signal (#21). R2 (no whistle) repeats end of set signal.
  - 3. R2 double whistles, holds coin up, joins ONE captain from each team, conducts coin toss ("serve" or "receive").
  - R2 communicates to R1 the result. R1 whistles and indicates serving team.
  - 5. R2 directs clock to start.





#### END OF MATCH

- 1. R1 whistles, awards winning point, shows fault. R2 (no whistle) follows by repeating point and fault.
- 2. R1 whistles, shows "End of Set" signal (#21). R2 (no whistle) repeats end of set signal.
- 3. R1 instructs teams to endlines.
- R1 whistles and instructs teams to attack lines for congratulatory comments.
- 5. R1 goes to score table side, collects belongings, and dons mask. R1 and R2 leave facility together, debriefing in the parking lot





#### <u>REMINDERS</u>

- Contact partner (text, email, phone call) approximately one week before scheduled match to confirm date, location, and time.
- Megaphones for cheer squads only.
- Fans must stay in stands; only cheer squad is allowed on surface.
- Cheer squad must stay on their team's side of centerline.





#### **REMINDERS**

- R2 does NOT show change of court.
- Time Outs:
  - One or both teams in huddle at :45 second mark
    - R2 double whistles warning
    - Both teams on court before or at :60 seconds: Horn sounds
  - Both teams on court before :45 second mark: R2 double whistles and immediately instructs horn to sound





#### **REMINDERS**

- Whenever R2 initiates a call,
  - R1 waits for R2 to step to side of fault and signal fault (with player number if net violation).
  - R1 awards point. R2 follows R1 in awarding point. (R2 is done signaling.)
  - R1 <u>shows fault</u> (with player number if net violation).

#### Significant Rules Changes 2020-2021

- Protective face masks may be worn.
- Late submission of roster results in administrative yellow card.
- Teams may correct inaccurate line-up.
- Head coach does not sit for unsporting yellow card.
- Substitution mechanics are now closed fists.
