- Rule Changes and Points of Emphasis 2017-2018
  - Solid libero jersey varsity only
    - Subvarsity: Clearly contrasting
  - Attack line must be solid and of one color
  - Ending time out and between set interval with warning (double) whistle and horn
  - Omitted: Illegal substitution signal



- Rule Changes and Points of Emphasis 2017-2018
  - Defined: Replay
    - Part of a single play action.
    - Once signaled, no requests (time out, service order, lineup check, substitution, libero replacement, etc.) may be recognized until after the rally is completed.
  - Point of emphasis: R2 getting to the fault side before initiating mechanics



- Rule Changes and Points of Emphasis 2018-2019
  - Word change: 2-4-1b
    - Another player Team members may not assist a player who is making an attempt to play a ball.
    - NO ONE on the bench may assist a player (coach, manager, etc.).

- Rule Changes and Points of Emphasis 2018-2019
  - New: 5-5-3b(10)
    - Additional R2 Responsibility (Responsibilities During Match – Case Book)
      - "[The Second Referee is to] ensure that the head coach, when standing during play, maintains a position in the <u>replacement zone</u> no closer than 6 feet from the sideline" (and not standing beyond the endline).

- Rule Changes and Points of Emphasis 2018-2019
  - New: 5-5-3b(13), 5-5-3b(20), 5-8-3a
    - "When multiple courts are in use, the second referee may end a time out or interval between sets with a whistle."



- Rule Changes and Points of Emphasis 2018-2019
  - New: 9-8-2 Exception and 11-4-1b
    - When a replay is signaled due to an injury/illness and the injured/ill player cannot continue play, the head coach may request a substitute or complete a legal libero replacement for the injured/ill player or take a team time out(s) if the team has remaining time outs.
    - This gives the coach an added option.

- Rule Changes and Points of Emphasis 2018-2019
  - Unnecessary Delay
    - New: 10-2 Penalties 2
      - "After a team is charged with unnecessary delay, no further substitutions may be requested by that team until the next completed rally."
    - Proper mechanics
      - Ignore mechanigram in handout (do NOT drop arm to court)



- Rule Changes and Points of Emphasis 2018-2019
  - New: 11-5-3
    - "Between sets, teams may warm up in their playing area. Volleyballs may not be hit over the net."
