Reminders

- Masks (per TASO)
 - Masks are to be a solid color with no logo or design.
 - The preferred colors are black or white.



Reminders

- Subvarsity Deciding Set
 - Non-district matches: 25 (no cap)
 - District matches: 25 (no cap) unless district rules otherwise
 - Verify with home coach before the coaches'/captains' meeting



Reminders

- Substitutions (R2)
 - Closed fists
 - Make sure the table and you have the sub recorded before returning court to R1
 - Scan benches to be aware of subs (and TO's)



Reminders

- Call Initiated By R2 (R2 Duties)
 - Net violation, centerline violation, out of rotation receiving team, antennae fault R2 side
 - Rare instances – back row violation, down ball
- GIVE THE FAULT FIRST
- Wait for R1 to award the point and follow R1



Reminders

- Call Initiated By R2 (R1 Duties)
 - WAIT until R2 shows the fault sequence
 - Award the point
 - Repeat player number if net violation



Reminders

- Check Roster
 - Check numbers or at least verify with head coach the accuracy of the roster



Reminders

- If you notice players that have spandex with logos completely around the waistband, speak to the coaches.
- They can be assessed illegal uniforms.



Reminders

- Incorrect Lineup
 - The only time a lineup may be changed is due to injury.
 - If a coach makes a mistake and the lineup has been recorded, it may not be changed.
 - If a substitute is requested prior to the start of the set, follow sub procedures and allow the sub.



Reminders

- Coach does not need to sit after being assessed a yellow card.
- This applies to both YUD's (yellow unnecessary delays) and sporting infractions.



Reminders

- Contact your partner days prior to the match and verify times, dates, and number of matches.



REMINDERS

- Megaphones for cheer squads only.
- Fans must stay in stands; only cheer squad is allowed on surface.
- Cheer squad must stay on their team's side of centerline.



REMINDERS

- Time Outs:
 - One or both teams in huddle at :45 second mark
 - R2 double whistles warning
 - Both teams on court before or at :60 seconds: Horn sounds
 - Both teams on court before :45 second mark: R2 double whistles and immediately instructs horn to sound
- R2: Make sure ALL players are on court before ending a time out prematurely.
