## <u>Reminder</u>

- Contact partner (text, email, phone call) approximately one week before scheduled match to confirm date, location, and time.
  - If you get no response, call. Keep trying until you make contact.





#### **Coaches/Captains Meeting**

- R2: Accept roster from coaches.
- Verify uniform legality.
- Ask if coaches prefer to switch or remain on same side.
  - Both coaches must agree to remain on same side; otherwise they switch.
- Ask coaches if they will shake hands at the net or wave at the attack line before and after the match.
- Determine warm-up time (5-5-2 vs. 6-6)





#### **During Warm-Up**

- Be observant of illegal uniforms (logo completely around spandex).
  - Suggestion: Remind both coaches of the penalty if seen during play (YUD – yellow unnecessary delay) and player must be replaced by substitution.





#### Time Outs

- R2 shows TO signal and points to middle of court (similar to "ball down" signal).
- At the beginning of the TO, R2 shows R1 at shoulder level the number of TO's used by each team.
- If one or both teams in huddle at :15 second mark,
  - R2 double whistles warning
  - Both teams on court before or at :00 seconds: Horn sounds
- Both teams on court before :15 second mark: R2 double whistles and immediately instructs horn to sound
- Both R1 and R2 show the number of TO's used by each each team at head height.





#### **End of Set**

- R2 does NOT show change of court (if switching) or release to bench (if staying on same sides).
- If teams switch, R2 facilitates that the 6 players on court on the right side immediately go around R1 to the opposite court. (Team members on bench bring water, etc., to the other side.)





#### **REMINDERS**

- Whenever R2 initiates a call,
  - R1 <u>waits</u> for R2 to step to side of fault and signal fault (with player number if net violation).
  - R1 awards point. R2 follows R1 in awarding point. (R2 is done signaling.)
  - R1 shows fault (with player number if net violation).
